The Honorary Event Chair of the luncheon was Jared Kushner (Kushner Companies) who introduced his long-time friend Mayor Booker.

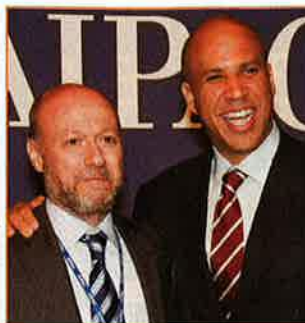
